## INTERNATIONAL STUDENT FINANCIAL GUARANTEE FORM

The United States Department of Homeland Security (DHS) regulations require documentation that sufficient financial resources are available to meet a student's prospective educational and living expenses while in the U.S. Therefore, Hartford International University requires a guarantee of financial resources from each applicant who expects to obtain or maintain F-1/J-1 student status.

- Ensure all documents are clear and concise, listing the student's or account holder(s) name and in English. NOTE: Some financial documentation may require a stamp for authenticity.
- Acceptable sources of funding include: checking and savings account bank statements with a current balance, approved loan documents, and scholarships.
